

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All Share Index lost 0.01% to settle the year to date return of the market at (14.52%).

The Index closed at 30,738.92 basis point against the previous close of 30,741.88 basis point while Market Capitalization closed at 16,062,008,723,707.70 against previous close of 16,068,283,630,371.20. Volume traded increased by 50.16% from 286,446,480 to 430,121,026 while the total value of stocks traded increased by 113.89% from 3,094,793,795.23 to 6,619,323,528.76 in 4,319 deals compared to 2,889 deals traded previously.

TRANSCORP, LEARNAFRCA, AFRIPRUD, LIVESTOCK and MBENEFIT top the gainers table by gaining 9.86%, 9.52%, 9.35%, 8.99% and 5.00% while LINKASSURE, ABCTRANS, CHIPLC, UNIONDAC and FIDSON top the losers table by shedding 8.89%, 8.82%, 8.11%, 7.41% and 6.82%.
