The Nigerian equity market closed negative as the All Share Index lost 1.53% to settle the year to date return of the market at (27.57%).

The Index closed at 34,242.83 basis point against the previous close of 34,774.08 basis point while Market Capitalization closed at 17,892,907,955,709.30 against previous close of 18,170,505,827,376.10. Volume traded increased by 1300.09% from 668,531,406 to 9,360,014,746 while the total value of stocks traded increased by 53.15% from 7,849,218,445.68 to 12,021,146,397.74 in 8,712 deals compared to 10,319 deals traded previously.

BOCGAS, GLAXOSMITH, CONOIL, MBENEFIT and UNIONDAC top the gainers table by gaining 9.96%, 9.56%, 9.45%, 7.69% and 7.69% while OANDO, WAPIC, PORTPAINT, LIVESTOCK and CADBURY top the losers table by shedding 10.00%, 10.00%, 9.97%, 9.92% and 9.85%.
