Dear Esteemed Investor.

The Nigerian equity market closed positive as the All Share Index gained 1.68% to settle the year to date return of the market at (29.71%).

The Index closed at 34,818.01 basis point against the previous close of 34,242.83 basis point while Market Capitalization closed at 18,193,455,757,000.50 against previous close of 17,892,907,955,709.30. Volume traded decreased by 92.94% from 9,360,014,746 to 661,132,435 while the total value of stocks traded decreased by 30.97% from 12,021,146,397.74 to 8,298,141,137.68 in 7,324 deals compared to 8,712 deals traded previously.

LINKASSURE, STERLNBANK, WAPCO, HONYFLOUR and ABCTRANS top the gainers table by gaining 10.00%, 10.00%, 9.55%, 9.43% and 9.38% while CORNERST, REGALINS, MBENEFIT, UNIONDAC and UNITYBNK top the losers table by shedding 8.62%, 8.33%, 7.14%, 7.14% and 6.98%.
