

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All Share Index lost 0.04% to settle the year to date return of the market at (27.12%).

The Index closed at 34,121.78 basis point against the previous close of 34,136.82 basis point while Market Capitalization closed at 17,829,656,263,542.80 against previous close of 17,837,516,502,980.60. Volume traded increased by 64.69% from 344,902,718 to 568,036,776 while the total value of stocks traded increased by 73.52% from 4,222,000,334.57 to 7,326,148,724.08 in 8,928 deals compared to 6,565 deals traded previously.
