Dear Esteemed Investor.

The Nigerian equity market closed positive as the All Share Index gained 0.64% to settle the year to date return of the market at (27.94%).

The Index closed at 34,340.56 basis point against the previous close of 34,121.78 basis point while Market Capitalization closed at 17,943,034,851,131.10 against previous close of 17,829,656,263,542.80. Volume traded decreased by 35.67% from 568,036,776 to 365,413,814 while the total value of stocks traded decreased by 35.96% from 7,326,148,724.08 to 4,691,780,878.53 in 6,325 deals compared to 8,928 deals traded previously.

UPDCREIT, UCAP, FIDELITYBK, MBENEFIT and CORNERST top the gainers table by gaining 9.64%, 9.52%, 9.47%, 8.70% and 8.62% while ETERNA, FIDSON, CHAMPION, JBERGER and CHAMS top the losers table by shedding 9.98%, 9.81%, 9.43%, 8.95% and 8.33%.
