## Dear Esteemed Investor.

The Nigerian equity market closed positive as the All Share Index gained 1.25% to settle the year to date return of the market at (29.53%).

The Index closed at 34,769.00 basis point against the previous close of 34,340.56 basis point while Market Capitalization closed at 18,166,896,456,072.60 against previous close of 17,943,034,851,131.10. Volume traded increased by 19.02% from 365,413,814 to 434,922,233 while the total value of stocks traded increased by 47.35% from 4,691,780,878.53 to 6,913,130,582.69 in 7,029 deals compared to 6,325 deals traded previously.

MAYBAKER, UPDCREIT, ETERNA, FLOURMILL and MANSARD top the gainers table by gaining 10.00%, 9.89%, 9.88%, 9.84% and 9.83% while TRANSEXPR, ABCTRANS, CORNERST, UAC-PROP and OANDO top the losers table by shedding 9.38%, 8.57%, 7.94%, 6.82% and 6.55%.
