

Dear Esteemed Investor,

The Nigerian equity market closed positive as the All Share Index gained 0.45% to settle the year to date return of the market at (30.55%).

The Index closed at 35,042.14 basis point against the previous close of 34,885.51 basis point while Market Capitalization closed at 18,309,612,150,340.40 against previous close of 18,227,773,970,952.10. Volume traded increased by 118.38% from 190,280,082 to 415,531,476 while the total value of stocks traded increased by 47.05% from 3,330,705,964.01 to 4,897,914,189.66 in 5,267 deals compared to 3,976 deals traded previously.

AIICO, AIRTELAFRI, TRIPPLEG, JAPAULOIL and UNIONDAC top the gainers table by gaining 10.00%, 10.00%, 9.09%, 8.33% and 8.00% while NNFM, CUTIX, FIDSON, NEIMETH and LEARNAFRCA top the losers table by shedding 10.00%, 10.00%, 9.87%, 9.63% and 9.57%.
