

Dear Esteemed Investor,

The Nigerian equity market closed positive as the All Share Index gained 0.30% to settle the year to date return of the market at (30.94%).

The Index closed at 35,147.62 basis point against the previous close of 35,042.14 basis point while Market Capitalization closed at 18,364,778,888,623.80 against previous close of 18,309,612,150,340.40. Volume traded decreased by 25.83% from 415,531,476 to 308,180,951 while the total value of stocks traded decreased by 30.53% from 4,897,914,189.66 to 3,402,641,102.78 in 4,515 deals compared to 5,267 deals traded previously.

CAVERTON, CUTIX, AllCO, CHAMS and MCNICHOLS top the gainers table by gaining 9.88%, 9.80%, 9.78%, 8.70% and 8.51% while CORNERST, CHIPLC, PRESTIGE, LASACO and MBENEFIT top the losers table by shedding 10.00%, 9.68%, 9.09%, 8.82% and 8.70%.
