

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All Share Index lost 0.26% to settle the year to date return of the market at (30.60%).

The Index closed at 35,056.82 basis point against the previous close of 35,147.62 basis point while Market Capitalization closed at 18,322,807,441,643.30 against previous close of 18,364,778,888,623.80. Volume traded increased by 19.72% from 308,180,951 to 368,966,347 while the total value of stocks traded increased by 61.37% from 3,402,641,102.78 to 5,490,983,429.62 in 4,598 deals compared to 4,515 deals traded previously.
