Dear Esteemed Investor.

The Nigerian equity market closed negative as the All-Share Index lost 0.04% to settle the year-to-date return of the market at (30.47%).

The Index closed at 35,021.26 basis point against the previous close of 35,033.74 basis point while Market Capitalization closed at 18,304,225,874,614.80 against previous close of 18,310,749,158,423.90. Volume traded decreased by 7.76% from 306,918,503 to 283,090,838 while the total value of stocks traded increased by 4.46% from 3,274,179,166.89 to 3,420,166,037.32 in 3,855 deals compared to 4,500 deals traded previously.

FTNCOCOA, UNIONDAC, CHAMS, UNITYBNK and REGALINS top the gainers table by gaining 8.82%, 8.00%, 4.76%, 4.69% and 4.55% while ROYALEX, ARDOVA, MBENEFIT, CHAMPION and FIDSON top the losers table by shedding 8.70%, 8.65%, 8.33%, 8.16% and 7.79%.
