## Dear Esteemed Investor.

The Nigerian equity market closed positive as the All-Share Index gained 1.73% to settle the year-to-date return of the market at (29.81%).

The Index closed at 34,843.44 basis point against the previous close of 34,250.74 basis point while Market Capitalization closed at 18,211,283,288,369.90 against previous close of 17,901,502,162,379.90. Volume traded decreased by 73.86% from 796,064,572 to 208,094,710 while the total value of stocks traded decreased by 17.13% from 4,464,975,124.14 to 3,700,327,636.86 in 4,154 deals compared to 4,810 deals traded previously.

AIRTELAFRI, ROYALEX, AIICO, FTNCOCOA and NEIMETH top the gainers table by gaining 10.00%, 9.52%, 9.52%, 9.09% and 9.09% while PRESTIGE, INTBREW, CUTIX, NASCON and JAIZBANK top the losers table by shedding 10.00%, 9.89%, 9.47%, 9.38% and 8.82%.
