Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 1.83% to settle the year-to-date return of the market at (0.31%).

The Index closed at 40,396.14 basis point against the previous close of 41,147.39 basis point while Market Capitalization closed at 21,122,338,148,448.10 against previous close of 21,515,154,232,933.50. Volume traded increased by 119.73% from 211,929,100 to 465,673,145 while the total value of stocks traded increased by 263.56% from 1,407,693,668.50 to 5,117,857,040.73 in 7,573 deals compared to 3,438 deals traded previously.

BOCGAS, NEM, SOVRENINS, JAPAULGOLD and LIVESTOCK top the gainers table by gaining 9.72%, 9.50%, 9.09%, 8.82% and 8.63% while OANDO, FTNCOCOA, MAYBAKER, FBNH and ABCTRANS are the top losers on the table by shedding 10.00%, 9.72%, 8.55%, 8.28% and 7.89%.
