

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.07% to settle the year-to-date return of the market at (1.94%).

The Index closed at 41,051.63 basis point against the previous close of 41,082.38 basis point while Market Capitalization closed at 21,474,567,146,907.70 against previous close of 21,490,651,619,650.90. Volume traded increased by 10.79% from 738,524,833 to 525,006,911 while the total value of stocks traded decreased by 34.76% from 4,172,808,923.45 to 5,337,098,659.01 in 5,965 deals compared to 7,396 deals traded previously.
