Dear Esteemed Investor.

The Nigerian equity market closed positive as the All-Share Index gained 0.83% to settle the year-to-date return of the market at (4.12%).

The Index closed at 41,930.73 basis point against the previous close of 41,584.94 basis point while Market Capitalization closed at 21,934,431,128,595.20 against previous close of 21,753,547,496,119.70. Volume traded increased by 16.18% from 467,886,480 to 543,597,202 while the total value of stocks traded increased by 31.55% from 5,565,767,469.95 to 7,321,959,683.47 in 6,770 deals compared to 5,990 deals traded previously.

CHIPLC, GUINEAINS, FIDSON, CHAMPION and LASACO top the gainers table by gaining 10.00%, 10.00%, 9.90%, 9.79% and 9.76% while SKYAVN, CORNERST, CAVERTON, UNIVINSURE and FTNCOCOA are the top losers on the table by shedding 10.00%, 9.72%, 9.41%, 8.70% and 8.33%.
