Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.13% to settle the year-to-date return of the market at (5.18%).

The Index closed at 42,357.90 basis point against the previous close of 42,412.66 basis point while Market Capitalization closed at 22,157,889,081,630.70 against previous close of 22,186,536,655,740.50. Volume traded decreased by 12.40% from 669,876,332 to 586,806,603 while the total value of stocks traded decreased by 8.61% from 6,591,818,638.10 to 6,024,018,923.16 in 7,611 deals compared to 6,663 deals traded previously.

HONYFLOUR, CHAMPION, MCNICHOLS, WAPIC and JAIZBANK top the gainers table by gaining 10.00%, 9.97%, 9.80%, 9.26% and 9.23% while ROYALEX, GUINEAINS, AFRINSURE, JBERGER and CHIPLC are the top losers on the table by shedding 10.00%, 9.09%, 8.00%, 7.28% and 4.55%.
