

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.10% to settle the year-to-date return of the market at (4.29%).

The Index closed at 42,000.01 basis point against the previous close of 42,043.79 basis point while Market Capitalization closed at 21,970,672,771,670.50 against previous close of 21,993,576,026,960.90. Volume traded decreased by 9.21% from 556,023,267 to 504,837,137 while the total value of stocks traded increased by 10.97% from 4,785,424,814.31 to 5,310,198,623.61 in 5,887 deals compared to 7,110 deals traded previously.

NCR, CHIPLC, PRESTIGE, MCNICHOLS and ETERNA top the gainers table by gaining 9.94%, 9.52%, 9.09%, 8.93% and 7.69% while LINKASSURE, CHAMPION, REGALINS, AFRINSURE and WAPIC are the top losers on the table by shedding 9.88%, 9.84%, 9.38%, 9.09% and 8.47%.
