

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.13% to settle the year-to-date return of the market at (3.08%).

The Index closed at 41,510.16 basis point against the previous close of 41,564.31 basis point while Market Capitalization closed at 21,715,821,832,389.10 against previous close of 21,744,150,374,341.70. Volume traded decreased by 10.15% from 340,489,502 to 305,927,696 while the total value of stocks traded increased by 49.65% from 2,640,566,585.77 to 3,951,732,662.82 in 4,969 deals compared to 5,263 deals traded previously.
