Dear Esteemed Investor.

The Nigerian equity market closed positive as the All-Share Index gained 0.33% to settle the year-to-date return of the market at (0.75%).

The Index closed at 40,571.67 basis point against the previous close of 40,439.85 basis point while Market Capitalization closed at 21,224,857,217,308.60 against previous close of 21,155,896,074,753.60. Volume traded decreased by 47.87% from 395,623,321 to 206,243,282 while the total value of stocks traded decreased by 58.31% from 5,190,444,983.51 to 2,163,668,659.57 in 4,264 deals compared to 5,321 deals traded previously.

SEPLAT, JAPAULGOLD, MBENEFIT, AllCO and MULTIVERSE top the gainers table by gaining 10.00%, 9.86%, 9.52%, 9.26% and 9.09% while CONOIL, ROYALEX, RTBRISCOE, CHIPLC and SOVRENINS are the top losers on the table by shedding 10.00%, 10.00%, 9.09%, 8.70% and 7.69%.
