Dear Esteemed Investor.

The Nigerian equity market closed negative as the All-Share Index lost 0.08% to settle the year-to-date return of the market at (-0.29%).

The Index closed at 40,164.86 basis point against the previous close of 40,154.09 basis point while Market Capitalization closed at 21,014,450,996,144.30 against previous close of 21,008,819,732,044.60. Volume traded increased by 16.80% from 289,338,344 to 337,955,177 while the total value of stocks traded increased by 7.59% from 3,573,971,068.65 to 3,845,103,251.25 in 5,232 deals compared to 4,953 deals traded previously.

AllCO, LIVESTOCK, FLOURMILL, ZENITHBANK and CUTIX top the gainers table by gaining 7.14%, 7.14%, 6.16%, 4.84% and 4.65% while SUNUASSUR, LASACO, AFRIPRUD, ABCTRANS and UPL are the top losers on the table by shedding 9.88%, 9.87%, 9.85%, 8.57% and 8.53%.
