Dear Esteemed Investor.

The Nigerian equity market closed negative as the All-Share Index lost 0.74% to settle the year-to-date return of the market at (-1.17%).

The Index closed at 39,799.89 basis point against the previous close of 40,095.49 basis point while Market Capitalization closed at 20,823,496,375,394.20 against previous close of 20,978,157,840,462.60. Volume traded increased by 55.58% from 326,042,400 to 507,254,782 while the total value of stocks traded decreased by 34.22% from 3,713,147,595.84 to 2,442,549,597.84 in 4,465 deals compared to 4,567 deals traded previously.

LASACO, MBENEFIT, COURTVILLE, OANDO and NAHCO top the gainers table by gaining 9.82%, 8.11%, 5.00%, 2.99% and 2.70% while CHAMPION, WEMABANK, SUNUASSUR, AFRIPRUD and MANSARD are the top losers on the table by shedding 10.00%, 10.00%, 9.59%, 5.74% and 5.36%.
