

Dear Esteemed Investor,

The Nigerian equity market closed positive as the All-Share Index gained 0.33% to settle the year-to-date return of the market at (-0.84%).

The Index closed at 39,931.63 basis point against the previous close of 39,799.89 basis point while Market Capitalization closed at 20,892,423,755,848.40 against previous close of 20,823,496,375,394.20. Volume traded increased by 7.24% from 507,254,782 to 543,986,690 while the total value of stocks traded decreased by 22.70% from 2,442,549,597.84 to 1,888,199,436.73 in 4,673 deals compared to 4,465 deals traded previously.

UACN, AIICO, VERITASKAP, BUACEMENT and NEIMETH top the gainers table by gaining 6.67%, 5.22%, 5.00%, 3.82% and 2.73% while NASCON, CHAMPION, PZ, LASACO and ROYALEX are the top losers on the table by shedding 9.97%, 9.92%, 9.43%, 8.94% and 7.41%.
