

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.59% to settle the year-to-date return of the market at (-1.42%).

The Index closed at 39,697.62 basis point against the previous close of 39,931.63 basis point while Market Capitalization closed at 20,769,990,828,591.30 against previous close of 20,892,423,755,848.40. Volume traded decreased by 59.08% from 543,986,690 to 222,573,570 while the total value of stocks traded increased by 185.47% from 1,888,199,436.73 to 5,390,312,418.19 in 4,470 deals compared to 4,673 deals traded previously.
