Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.40% to settle the year-to-date return of the market at (-2.25%).

The Index closed at 39,364.67 basis point against the previous close of 39,522.06 basis point while Market Capitalization closed at 20,595,790,200,130.40 against previous close of 20,678,135,421,497.80. Volume traded increased by 101.84% from 244,342,845 to 493,172,597 while the total value of stocks traded increased by 14.40% from 4,128,027,466.04 to 4,722,499,530.20 in 5,486 deals compared to 4,714 deals traded previously.

UPL, MORISON, CAP, WAPCO and LIVESTOCK top the gainers table by gaining 9.91%, 9.09%, 5.26%, 3.59% and 3.17% while FIDSON, NNFM, ENAMELWA, NEM and NCR are the top losers on the table by shedding 10.00%, 9.97%, 9.95%, 9.95% and 9.91%.
