Dear Esteemed Investor,

The Nigerian equity market closed positive as the All-Share Index gained 0.17% to settle the year-to-date return of the market at (-2.17%).

The Index closed at 39,396.57 basis point against the previous close of 39,331.61 basis point while Market Capitalization closed at 20,612,481,990,370.60 against previous close of 20,578,490,480,591.90. Volume traded decreased by 49.42% from 587,742,048 to 297,269,586 while the total value of stocks traded decreased by 76.83% from 13,615,384,435.42 to 3,154,329,880.49 in 4,655 deals compared to 4,895 deals traded previously.
