## Dear Esteemed Investor.

The Nigerian equity market closed negative as the All-Share Index lost 0.60% to settle the year-to-date return of the market at (-3.91%).

The Index closed at 38,697.17 basis point against the previous close of 38,931.25 basis point while Market Capitalization closed at 20,246,551,364,424.30 against previous close of 20,369,019,754,383.60. Volume traded decreased by 54.01% from 368,216,369 to 169,354,003 while the total value of stocks traded decreased by 56.83% from 4,909,785,806.54 to 2,119,751,804.52 in 3,568 deals compared to 4,437 deals traded previously.

SMURFIT, INTBREW, CHAMPION, ROYALEX and LIVESTOCK top the gainers table by gaining 10.00%, 9.89%, 9.09%, 8.33% and 7.65% while AFRINSURE, SOVRENINS, MBENEFIT, UPL and LIVESTOCK are the top losers on the table by shedding 8.33%, 7.14%, 7.14%, 4.92% and 4.41%.
