Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.13% to settle the year-to-date return of the market at (-4.03%).

The Index closed at 38,648.48 basis point against the previous close of 38,697.17 basis point while Market Capitalization closed at 20,221,077,235,147.50 against previous close of 20,246,551,364,424.30. Volume traded increased by 73.58% from 169,354,003 to 293,970,400 while the total value of stocks traded increased by 77.84% from 2,119,751,804.52 to 3,769,759,464.28 in 3,760 deals compared to 3,568 deals traded previously.

REGALINS, FLOURMILL, NEM, NNFM and LIVESTOCK top the gainers table by gaining 10.00%, 10.00%, 9.73%, 9.71% and 9.29% while SFSREIT, UNITYBNK, AFRINSURE, SOVRENINS and WEMABANK are the top losers on the table by shedding 9.96%, 9.59%, 9.09%, 7.69% and 6.15%.
