

Dear Esteemed Investor,

The Nigerian equity market closed positive as the All-Share Index gained 0.89% to settle the year-to-date return of the market at (-3.84%).

The Index closed at 38,722.87 basis point against the previous close of 38,382.39 basis point while Market Capitalization closed at 20,259,994,451,966.60 against previous close of 20,081,857,298,706.80. Volume traded decreased by 4.60% from 290,615,950 to 277,235,456 while the total value of stocks traded decreased by 24.00% from 4,017,766,192.15 to 3,053,339,115.70 in 4,299 deals compared to 4,311 deals traded previously.
