

## **Daily Market Update**

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.33% to settle the year-to-date return of the market at (-3.36%).

The Index closed at 38,916.74 basis point against the previous close of 39,045.13 basis point while Market Capitalization closed at 20,361,439,326,144.40 against previous close of 20,428,617,641,680.10. Volume traded decreased by 31.04% from 347,173,467 to 239,421,124 while the total value of stocks traded decreased by 17.40% from 2,803,263,597.35 to 2,315,549,915.21 in 4,450 deals compared to 3,990 deals traded previously.

ROYALEX, UACN, JAPAULGOLD, CUTIX and LINKASSURE top the gainers table by gaining 10.00%, 10.00%, 9.76%, 9.31% and 9.09% while FTNCOCOA, NEM, UNITYBNK, REGALINS and LIVESTOCK are the top losers on the table by shedding 8.70%, 7.39%, 6.67%, 3.33% and 2.60%.
