

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.39% to settle the year-to-date return of the market at (-3.73%).

The Index closed at 38,766.61 basis point against the previous close of 38,916.74 basis point while Market Capitalization closed at 20,282,905,922,718.90 against previous close of 20,361,439,326,144.40. Volume traded decreased by 6.19% from 239,421,124 to 224,594,153 while the total value of stocks traded decreased by 7.43% from 2,315,549,915.21 to 2,143,445,981.33 in 4,675 deals compared to 4,450 deals traded previously.
