Dear Esteemed Investor,

The Nigerian equity market closed positive as the All-Share Index gained 0.07% to settle the year-to-date return of the market at (-3.65%).

The Index closed at 38,799.83 basis point against the previous close of 38,774.03 basis point while Market Capitalization closed at 20,300,284,175,782.20 against previous close of 20,286,783,974,042.80. Volume traded decreased by 59.23% from 356,461,102 to 145,331,844 while the total value of stocks traded decreased by 62.43% from 4,193,302,105.65 to 1,575,623,116.03 in 3,525 deals compared to 6,130 deals traded previously.

CHIPLC, JAPAULGOLD, OANDO, AllCO and ZENITHBANK top the gainers table by gaining 9.68%, 9.43%, 5.16%, 5.00% and 3.81% while ROYALEX, JAIZBANK, HONYFLOUR, DAARCOMM and LINKASSURE are the top losers on the table by shedding 7.69%, 6.06%, 5.04%, 4.76% and 4.76%.
