Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.40% to settle the year-to-date return of the market at (-3.87%).

The Index closed at 38,712.55 basis point against the previous close of 38,866.39 basis point while Market Capitalization closed at 20,253,767,459,403.00 against previous close of 20,335,107,890,966.90. Volume traded increased by 20.77% from 160,649,812 to 194,020,204 while the total value of stocks traded increased by 6.52% from 1,280,604,371.33 to 1,364,046,379.38 in 4,188 deals compared to 3,507 deals traded previously.

JAPAULGOLD, UAC-PROP, AFRIPRUD, ROYALEX and STERLNBANK top the gainers table by gaining 9.52%, 9.33%, 8.33%, 8.33% and 7.69% while STANBIC, GUINNESS, CUSTODIAN, NAHCO and PZ are the top losers on the table by shedding 9.94%, 9.93%, 8.40%, 7.73% and 5.15%.
