

Dear Esteemed Investor,

The Nigerian equity market closed negative as the All-Share Index lost 0.17% to settle the year-to-date return of the market at (-4.22%).

The Index closed at 38,571.89 basis point against the previous close of 38,636.15 basis point while Market Capitalization closed at 20,186,460,649,292.50 against previous close of 20,220,088,556,985.80. Volume traded increased by 14.89% from 278,036,018 to 319,432,480 while the total value of stocks traded decreased by 21.85% from 2,272,009,804.69 to 1,775,524,738.07 in 4,158 deals compared to 3,987 deals traded previously.

GUINNESS, FTNCOCOA, MORISON, HONYFLOUR and LIVESTOCK top the gainers table by gaining 10.00%, 9.30%, 9.30%, 9.17% and 6.74% while UAC-PROP, PZ, STUDPRESS, NNFM and CHAMS are the top losers on the table by shedding 10.00%, 9.78%, 9.50%, 9.26% and 9.09%.
