Dear Esteemed Investor,

The Nigerian equity market closed positive as the All-Share Index gained 0.61% to settle the year-to-date return of the market at (-3.63%).

The Index closed at 38,808.01 basis point against the previous close of 38,571.89 basis point while Market Capitalization closed at 20,310,032,560,194.10 against previous close of 20,186,460,649,292.50. Volume traded decreased by 17.82% from 319,432,480 to 262,510,300 while the total value of stocks traded increased by 37.32% from 1,775,524,738.07 to 2,438,156,731.32 in 3,525 deals compared to 4,158 deals traded previously.

CHAMS, UAC-PROP, GUINNESS, NNFM and PZ top the gainers table by gaining 10.00%, 9.72%, 9.26%, 9.18% and 8.43% while JAPAULGOLD, STERLNBANK, FCMB, MBENEFIT and GLAXOSMITH are the top losers on the table by shedding 10.00%, 9.76%, 8.90%, 8.11% and 5.88%.
