Dear Esteemed Investor.

The Nigerian equity market closed positive as the All-Share Index gained 0.43% to settle the year-to-date return of the market at (-3.12%).

The Index closed at **39,015.58** basis point against the previous close of **38,848.02** basis point while Market Capitalization closed at **20,418,663,676,029.80** against previous close of **20,330,971,451,764.80**. Volume traded decreased by 33.35% from **508,637,467**to **339,018,342**while the total value of stocks traded decreased by 91.58% from **32,101,291,046.21**to **2,703,177,525.43** in 4,324 deals compared to 4,203 deals traded previously.

PZ, HONYFLOUR, SOVRENINS, NEM and JOHNHOLT top the gainers table by gaining 10.00%, 10.00%, 8.00%, 7.50% and 5.88% while ROYALEX, PORTPAINT, FTNCOCOA, CHAMS and LIVESTOCK are the top losers on the table by shedding 10.00%, 9.90%, 8.89%, 4.55% and 2.70%.
